#### CRITERIA FOR UNDERGRADUATE ANNUAL GRANTS

Applicants must:

- (1) be a member in good standing with the Zeta Chapter of Phi Gamma Delta as confirmed by the Zeta Chapter Purple Legionnaire;
- (2) have lived in the Zeta Chapter House ever since becoming a member of Phi Gamma Delta (Zeta Chapter); exceptions include being married, or having signed a year-long housing contract BEFORE pledging, or living at home in Bloomington; successful applicants shall live in the Zeta Chapter House during the entire academic year the grant will be utilized;
- (3) maintain a cumulative GPA of 3.0 or higher on a 4.0 scale and be enrolled as a full-time student;
- (4) have served or be serving as an event or committee chairman on campus or within the chapter;
- (5) satisfy the UNIQUE requirement for a specific grant being applied for;
- (6) be regarded by the undergraduate chapter as a "Good Zeta Fiji";
- (7) have demonstrated a genuine sense of philanthropy;
- (8) have participated in at least one IM event for Zeta Chapter and/or have been a Little 500 Rider or Coach for Zeta Chapter;
- (9) have fulfilled all of your financial obligations to Zeta Chapter;
- (10) have recommended at least one candidate for Zeta's annual rush program.
